It is suggested that each industry decide prior to the first meeting of the hub who the representative will be and notify the Secretariat (Rob Duindam) of the persons contact details. Ideally, the representative should be in a position to represent their industry giving both strategic and practical input into discussions. The idea is to promote better communication and discussion on crime prevention issues that lead to practical and sustainable actions. At this stage Police are suggesting that

the first meeting of the Hub should proceed no later than mid November 2009.

- **Police to establish a secretariat to facilitate communication and action with representatives**

Police have established a Secretariat for the Forum. It will be lead by Inspector Rob Duindam. Rob is based at Police National Headquarters and works for the National Criminal Investigations Group and is in charge of planning and monitors the groups' work programs.
